c. The price discount relationship remain as follows:

Needi Scrubs. s price/discount relationship with the Government and with the Most Favored Customer, identified as Distributors, shall remain throughout the contract period, no less favorable to the Government than at the conclusions of negotiations, this is: For the life of the contract, the Government s basic discount will never be less than 5% and will always be at least 5% greater than the 0% basic discount granted to the MFC as shown in Attachment B herein.

d. The Economic Price Adjustment (EPA) Clause 552.216-70 applies to all items on this contract.

e. The current terms and conditions in effect for this option period are as follows:

Basic Discount: 5%

Quantity Discount: +10% at 100 Kits

Prompt Payment Discount: Net 30 Days

Delivery Terms: In accordance with the requirements of the task order

Warranty: The manufacturer s Standard Commercial Warranty applies

Foreign Items: Note the foreign items accepted and the applicable country. All items from non designated TAA countries have been excluded.

f. This modification incorporates the re-representation of size status (FAR 52.212-3( c ) into this contract.

g. The Industrial Funding Fee (IFF) is a separate collection mechanism and any increase or decrease in the fee does not change the price discount relationship stated above. The current IFF is .75% and should be calculated as follows:

Negotiated price divided by (1 minus .0075) which equates to Negotiated price divided by 0.9925. Example: ( $\$100,000 / 0.9925$ ) = \$100,755.67

All other terms and conditions remain in effect as originally accepted or subsequently changed by modification.
